## Established 1931, ND Legislature

## Statutory authority for all seed-related matters

- Federal Seed Act/USDA Cooperative Agreement
- Seed certification (field crops and potatoes)
- State Seed Laboratory
- State and Federal cooperative programs
- Enforcement of state and federal seed laws

Unique structure/mission (by comparison to peers)

- "One-Stop" function: Field crop and potato certification, seed regulatory enforcement, seed testing, foundation potato seed production

- Board of Directors, ag industry representation
- Self Funded- service fees

## Field Seed Certification (Largest program in U.S.)

- o 2500-3000 fields inspected
- o 7-8,000,000 bushels certified

#### Potato Seed Certification (2<sup>nd</sup> largest program in U.S.)

- 13-14,000 acres inspected
- o 600-700 fields inspected (3X)
- o 2,000,000 hundredweight inspected

## Laboratory Services

**Seed Laboratory**: support for field seed certification program. Germination, purity, noxious weed, trait bioassay testing. (15-20,000 tests per year)

**Diagnostic Laboratory**: support for field seed and potato certification programs. Seed health testing, variety identification, GMO testing, potato virus and disease testing. (2000-2500 tests per year)
